PRODUCT DISCLOSURE SHEET for Burglary Policy

1. What is this product about?

The basic burglary policy provides you with coverage for loss caused by actual forcible and violent entry of the premises on item insured such as stocks in trade, furniture fittings, plant & machinery and etc

2. What are the covers / benefits provided?

- ❖ Stolen
- ❖ Damaged by thieves
- ❖ Or if as consequence of such forcible and violent entry or any attempt thereat there occur any damages to the Premises falling to be borne by the insured

Duration of cover is for one year and you need to renew the policy annually

3. How much premium do I have to pay?

The total premium that you have to pay may vary depending on the underwriting requirements of the insurance company you opted:-

6. What are the major exclusions under this policy?

This policy does not cover certain losses such as

- ❖ Loss or damage in consequence of strike or riot
- ❖ Loss or damage occasioned by fire however caused
- ❖ Loss or damage to plate glass or any decoration or lettering thereon
- ❖ Loss of/or damage to deeds bonds bills of exchange promissory notes cheques money or securities for money coins medal stamps, stamps collections, jewellery watches, furs precious metal precious stones or articles composed of any of them documents of title to property contracts or other documents business books manuscripts curious sculptures rare books plan patterns mould model or design unless specifically mentioned
- ❖ Loss or damage happening whilst the premises are left without inhabitant
- ❖ Loss or damage directly or indirectly caused by or arising from or in consequence of or controlled by nuclear weapons material
- ❖ Loss or damage directly or indirectly occasioned by War, Civil War and any act of Terrorism
- ❖ Radioactive and nuclear energy risks

7. Can I cancel my policy?

You may cancel your policy by giving written notice to us. Upon cancellation you are entitled to a refund of the premium less premium based on our short period rates for the period of the policy which has been in force, subject to the minimum premium to be retained by us. No refund premium is allowed if there is a claim under the policy
