

Rental of AmFriends Cruiser for AmLife Insurance Berhad's Agency Force

Terms and Conditions

The AmFriends Cruiser is rented subject to the Terms and Conditions, which must be signed by all parties who are renting before pickup of the vehicle. Failure to comply or any unlawful permission will allow AmLife Insurance Berhad to impose money penalty on the respective parties.

Rental Charge

RM350 for 2 consecutive days. The rental is charged in periods of 48 hours from the date and time of checkout. A 48 hour (two days) minimum charge applies. A non-refundable RM200 will be deducted from the driver's commission account upon collection of vehicle. The remaining balance of RM150 will be deducted from the commission account upon returning of the vehicle. However, should the amount chargeable in the respective agent's commission account is not sufficient or nil; the respective agency / unit manager will act as guarantor and the guarantor's commission will be deducted accordingly.

Extension of Rental

Extension of rental beyond the original date must be authorised by AmLife Insurance Berhad. Please contact AmLife Insurance Berhad during office hours (weekdays only) if an extension is needed.

Cancellation / Amendments of rental

A RM150 will be deducted from your Commission should you fail to inform AmLife Insurance Berhad upon cancellation of rental 1 day prior the actual rental. Amendments to bookings are free of charge.

Age/Drivers License

The minimum age for driving the AmFriends Cruiser is 18. There is no maximum age. All drivers must possess a valid driving license and required to have their driver's license in their possession at all times whilst driving.

Exclusions

The party who rent the vehicle will be liable for the full value of the damage and/or loss where such damage or loss is sustained in circumstances including but not limited to the following:

- As a result of driver negligence.
- Where the vehicle is driven by an unauthorised driver i.e. a driver who does not possess a valid driving license.
- Driving under the influence of alcohol or illegal substances.
- Failure to obtain authorisation from AmLife Insurance Berhad to extend the pre-booked rental.
- Where the vehicle is taken beyond the borders of Peninsular Malaysia without the written permission of AmLife Insurance Berhad.
- Where a vehicle is driven on a road or surface not suitable for the vehicle type rented.
- Collisions where no other vehicle, person, animal or object is involved.
- Where there has been a material breach of the Terms and Conditions of the Rental Agreement.

- Damage to or loss of tyres, rims and hubcaps, water and under-carriage damage or for towing charges.
- Whilst the vehicle is used for racing, competitions, rallies, motor sporting events of a purpose which it is not licensed.
- A fine imposed due to regulatory authorities

Whereby the full value of the as said damage and or/loss will be deducted from the agent's respective commission account. However, should the amount chargeable in the commission account is not sufficient or nil; the respective agency / unit manager will act as guarantor and their commission will be deducted accordingly.

Personal Belongings and items stored in AmFriends Cruiser

Personal belongings and items (sales collaterals, display kit etc) given to the agency are not covered by the company's insurance.

Use of Vehicle

The vehicle may only be driven and used for AmLife Insurance Berhad's sales and business purposes. The vehicle may not be driven to transport passengers and/ or goods for reward, to propel or tow another vehicle, be driven to a place where there is a risk of civil unrest/political disturbance.

Damage to Vehicles

A damage report must be completed by the driver for any damage to the vehicle, however minor it is. If a collision occurs, a police report and case number must also be supplied when returning the vehicle. We strongly advise the driver to contact our AmLife Insurance Berhad's customer contact centre at 1300 80 3030 in the event of any damage. If this procedure is not followed, the insurance cover could become invalidated, leaving the driver liable for all damage. The vehicle is registered under **ALL** Drivers.

Delivery & Collection of Vehicle

Monday- Friday 9am- 5pm

Additional Charges

All fines and penalties incurred during the rental period are for the parties who rent the vehicles own account. Loss of keys will result in an applicable charge being impose upon the driver.

Fuel

The AmFriends Cruiser leaves with a half tank to be used by rental.

Rental Requirements

The party who rent the vehicle would be required to supply the following on pickup:

- Completed registration Form
- A copy of the drivers' license and I.C (new)

What's Included ?

- Vehicle's insurance coverage
- Sales collaterals and goodies for AmLife Insurance Berhad's sales and business purposes, e.g buntings, flyers, brochures, display kit etc.

What's Not included?

- Additional fuel
- Road Tolls, parking and traffic fines.
- Insurance for all drivers and passengers

Exclusions of Vehicle Insurance

- Death or bodily injury
- Consequential losses of any nature
- The loss of use of the vehicle
- Depreciation, wear and tear, rust and corrosion, mechanical or electrical or electronic breakdowns, equipment or computer malfunction, failures or Breakages to the vehicle except breakage of windscreen or windows
- Tyre and wheel damage, interior damage, damage to the roof, damage to the underside of the vehicle, damage to the glass parts of vehicle, wing mirrors, loss or damage to the car key, locks, vehicle documents and registration plates.
- Any loss or damage caused by or attributed to the act of cheating/criminal breach of trust.

Vehicle

It is recommended that you check the vehicle before using it (lights, indicators, tyres, etc). Any mechanical problems with the vehicle should be reported to AmLife Insurance Berhad as soon as possible.

AmLife Insurance Berhad accepts no responsibility whatsoever for loss, damage, injury or death, whether arising from negligence, breach of contract or any other cause.
