Other Key Terms

- Change of risk: You must inform us of any material changes during the policy period. This ensures that necessary amendments can be made and endorsed to your insurance policy.
- Limit of Liability: The limit of liability stated in Item 2 is for illustration purposes only. The actual limit of liability can be determined based on the liability exposure of your business operations, as it represents the maximum amount payable for any one occurrence giving rise
- Duty of Assured: You shall exercise reasonable care that only competent employees are employed, take all reasonable precautions to prevent accidents and comply with all statutory regulations and maintain all premises, furnishings, fittings, appliances and plant in sound condition.
- Excess: It is the amount of loss you have to bear before we indemnify you.
