- for Non-Policy holders, the towing service is limited to one person/vehicle only over the Campaign Period
- for Non-Policy holders, The Company, without cause, reserves the right to refuse towing; The Company would not be liable for any indirect consequence as a result of the towing or non-towing of the owner's vehicle

- The Company has discretion to amend the terms and conditions as and where necessary and applicable
- The Company's liability is limited to the towing charges/service only
- subject to the terms and conditions, there is no charge or payment for the towing services up to 50 kilometres per round trip.
