**Important Clause**

- \* Definition of Resident**
  - A citizen of Malaysia (this excludes a citizen who has obtained any permanent Resident status in any other country or territory outside Malaysia and is a Resident outside Malaysia);
  - A non-citizen of Malaysia who has obtained a permanent Resident status in Malaysia and is ordinarily residing in Malaysia;
  - A body corporate incorporated or established, or registered with/or approved by any authority, in Malaysia;
  - An unincorporated body registered with/or approved by any authority in Malaysia; or
  - The Government or any State Government.
- \*\* Definition of Non-Resident**
  - Any person other than a Resident;
  - An overseas branch, a subsidiary, regional office, sales office or representative office of a Resident company;
  - Embassies, Consulates, High Commissions, supranational or international organisations; or
  - A citizen of Malaysia who has obtained permanent Resident status in a country or a territory outside Malaysia and is residing outside Malaysia.
- Applicable only to Joint Accounts Holders**  
For Joint account between husband and wife [pursuant to the Law Reform (Marriage and Divorce Act 1976)], where one of the joint account holder is a Resident while the other is a Non-Resident, the joint account will be a Resident account.
