IMPORTANT NOTE: Please read this Product Disclosure Sheet before you decide to take out the Equipment All Risks Insurance Policy. Be sure to also read the general terms and conditions.

1. What is this product about?

This policy provides coverage for your mobile equipment which are not licensed for public road use. Mobile equipment means mechanically self-propelled vehicles and/or equipment such as mobile cranes, tractors, forklifts, excavators etc.

2. What are the covers/benefits provided?

This policy covers loss or damage to equipment, its accessories, spare parts and parts whilst thereon by:

- Accidental collision or overturning or collision or overturning consequent upon mechanical breakdown or consequent upon wear and tear
- Fire, external explosion, self-ignition or lightning
- Burglary or theft

Duration of cover is for one year. You need to renew your insurance policy annually.

The benefit(s) payable under this eligible policy is protected by PIDM up to limits. Please refer to PIDM's TIPS Brochure or contact Liberty General Insurance Berhad or PIDM (visit www.pidm.gov.my).

Pursuant to Paragraph 5 of Schedule 9 of the Financial Services Act 2013, if you are applying for this Insurance wholly for purposes unrelated to your trade, business or profession, you have a duty to take reasonable care not to make a misrepresentation in answering the questions in the Proposal Form and/or all the questions required by the Company fully and accurately and disclose any other matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied, otherwise it may result in avoidance of contract, claim denied or reduced, terms changed or varied, or contract terminated.

○ Non-Consumer Insurance Contract

Pursuant to Paragraph 4(1) of Schedule 9 of the Financial Services Act 2013, if you are applying for this Insurance for purposes related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in avoidance of contract, claim denied or reduced, terms changed or varied, or contract terminated.

This duty of disclosure for Consumer and Non-Consumer Insurance Contract shall continue until the time the contract is entered into, varied or renewed. You also have a duty to tell us immediately if at any time after your contract of insurance has been entered into, varied or renewed with us, any of the information given is inaccurate or has changed.

- You must inform your insurance intermediary or us in writing on any material changes during the policy period so that the necessary amendments are endorsed to your policy.
- You shall take all reasonable steps to safeguard the equipment insured from loss or damage and to maintain it in efficient condition.
- Excess, being the amount you have to bear before we indemnify you.
- You must ensure that the sum insured is adequate, otherwise average condition will apply for under insurance at the time of loss. You will be deemed to be self-insuring for the difference.
- This insurance is subjected to 60 days Premium Warranty, i.e. premium due must be paid and received by us within sixty (60) days from inception. Failing which, policy is automatically cancelled and we are entitled to the pro rata premium on the period we have been on risk.

6. What are the major exclusions under this policy?

This policy does not cover certain losses such as:

- Outside the Territorial Limit stated in the Policy Schedule
- While the equipment being used on a Road as defined in the Road Traffic Act
- Whilst the equipment is in transit (including the process of loading and unloading)
- Whilst the equipment is operated by an Authorized Driver/Operator who is under the influence of intoxicating liquor or drugs
- Loss of accessories and/or spare parts and/or parts unless the whole Equipment is stolen at the same time

Note: This list is non-exhaustive. Please refer to the policy document for the full list of exclusions under this policy.

7. Can I cancel my policy and how do I cancel it?

You may cancel your policy by giving a written notice to us. Upon cancellation, you are entitled to a refund of the premium based on our *Short Period Table for the period of the policy which has been in force, subject to the minimum premium to be retained by us.
